The national desertification monitoring system has been established since 1994, Total four round of national wide Macro monitoring survey have been conducted with an interval of five years. The fifth round monitoring survey results will be publicized in 2015. The monitoring system is formed by 4 components including Macro monitoring, thematic monitoring, positioning monitoring and dust and sand storm monitoring. Central government provides annual financial support for operation of the program. The monitoring system applies an integrated methodology combining ground survey with satellite based 3S technology(GIS, GPS and Remote sensing).

Development concessional loan from national development Bank and bank of agriculture 6. Business investment from private sectors and individuals encouraged by taxations exemption and interest free credit policy, 7. Fee and compensation payment for land rehabilitation from mining, industry companies or public infrastructure projects, 8. Cross region ecological or water conservation payment from government, 9. Co-financing for water and soil conservation and sand dune stabilization from Infrastructure construction programs, 10. Donation from private sectors, individuals, NGOs and CSOs, 11. The fund for implementation of the Convention in China is mainly from government budget, Both bilateral and multilateral cooperative support are decreased in the reporting period. There is neither new commitment on granted projects nor new commenced project bilaterally. the projects or program reported are only on-going projects. The on-going projects still play special role in improvement of SLM planning and introduction of new technology and concept of conservation. The project financed by the GEF provides technical assistance in programming new strategy on land degradation rehabilitation in next 10years. The Sino-Germany projects bring impacts on adjustment of the afforestation technical standard in dry land and introduction of ecological experience and education concept.

There is no national quantitative target. But the law of desertification control and prevention, and decision of the state council request the central and local government to increase financial resources allocation gradually with annual economic growth. And in fact, the resources allocation increase indeed.

To facilitate access to technology, the national government has been gradually increasing financial resources for innovation, collection, summarization, updating and dissemination of the technologies. More funding has been invested in application of technology in sustainable management of forestry, agriculture and animal husbandry. Special funding for new technology innovation, demonstration, application and field test are provided by the government. International cooperation on advanced technology introduction are placed as priority of the government. Subsidies and technical services are provided by the governments for farmers to use new and environmental friendly technology through forestry service station system and agriculture technology extension service system. Private company engaged in high tech and technical services for forest and

agriculture are also get support from the government.
