1. The special DLDD monitoring system in the country does not exist, but there is a State environmental monitoring (CM Decree 111 of 2002). Six responsible ministries and agencies involved in monitoring: (i) State Committee on Nature Protection responsible: monitoring of pollution sources and monitoring of terrestrial ecosystems, biodiversity; (ii) Uzhydromet: monitoring of air pollution, pollution of surface (natural streams) water, soil, background monitoring; monitoring of agricultural land. Meteorological, hydrological, agricultural meteorological observation and monitoring of hazards; (iii) Ministry of Agriculture and Water Resources: monitoring the quantity and quality of irrigation and drainage water; monitoring of the salinity of irrigated lands, water table and salinity of ground water; monitoring of technical condition of irrigation infrastructure; (iv) Ministry of Geology: monitoring of groundwater contamination and hazardous geological processes; (v) Goszemgeodezkadastre: monitoring of land quality; (vi) Ministry of Health: sanitary-hygienic monitoring of the environment;

1. In the framework of the multi-country CACILM project "Capacity Building for SLM" (2010-2012.) conducted 20 capacity-building activities (TOTs, training on SLM best practices, field visits for target groups (NCC, decision makers, CTIs, local authorities, etc), scientific workshop and stakeholder dialogs, etc.), in the context of SLM and DLDD in target areas of Uzbekistan, for different target groups. As a result, about 700 people have increased their capacity (200 women, 500 men).
2. Conducts annual training for government officials in agriculture and water sectors in all regions of Uzbekistan. There are extension courses in the ministries and organizations of the country. GEF Small Grants Programme are implemented for the national CSOs project activities. The country hosts the annual Farmers Days and Innovative Fairs.
3. Under the NEAP for 2013-2017 organized tele- and radio programs, meetings, press Conferences, briefings, media tour with the participation of NGOs and the media; compulsory activities dedicated international days related to environmental protections and sustainable development, to combat desertification, climate change, etc.
